HANDICAP GOLF CART APPLICATION

(you must have state-issued handicap placard to apply)

- Any golf carts used as a substitute handicapped vehicle, shall be admitted to the premises under the following terms and conditions:
  - The cart must be registered immediately upon entering the show grounds before it may be operated.
- Tractors, garden tractors, ATV's, gators and go-carts will not be accepted as transportation and do not meet requirements to be included as a handicapped vehicle. These types of vehicles will not be permitted on the show grounds.
- Those operating golf carts as a handicapped conveyance must sign a Waiver of Liability protecting the Association, its officers, directors, members and the land owners from any liability caused by the vehicle. The association reserves the right to require proof of liability insurance naming Nittany Antique Machinery Association, Inc., and Penns Cave Inc., as the additional insured.
- These approved vehicles will not be allowed in the flea market area between the hours of 9:00am and 5:00pm.
- Those operating golf carts must have a valid driver's license. No one under age 16 is permitted to operate a golf cart at anytime.
- Total number of passengers on golf cart must not exceed designed seating capacity.
- If operated at night they must have a permanently installed light system with headlights and tail lights.
- Golf cart credential must be displayed on the hood/windshield of the golf cart. Credentials wrapped around the steering wheel are not acceptable.
- The Association, at the discretion of any official of the Association, shall have the right to expel and ban any vehicle and its owner and/or operator from the grounds that is reported or found to be operated in an unsafe manner or not meeting the above rules and regulations. Any cart that is not registered and/or properly displaying the registration will be expelled from the grounds.
- Non-handicapped golf carts shall be permitted on the grounds only for the use by NAMA staff in the performance of their duties. These carts will be so identified with NAMA Staff placards.
